OUR UCONN PUBLIC HEALTH CODE OF ETHICS

Academic institutions and programs are known for their individual traditions, and this is nowhere more true than in professional programs and schools. For the UConn Public Health Program, one tradition that presents itself at our annual graduate dinner relates to our Code of Ethics. In an evening of joy and collegiality, a highlight is always the voluntary signing of our code of ethics by each of the graduating students who wishes to participate. Each of these graduating students volunteers to sign the code of ethics and places it in our program notebook so that we now have signed codes of ethics from over 180 UConn public health graduates.

The code is as meaningful today as it was when we initiated this tradition 5 years ago, as such debacles as the current Flint, Michigan lead poisoning case has revealed. So we think it is appropriate at this time of year that all of us review the Code of Ethics and apply it to all that we do.

University of Connecticut Public Health Program Code of Ethics

Having earned a Public Health Degree, I understand my duty to protect and support policy that benefits the public's health and well-being. I further understand my obligation to earn and maintain the respect of the public and other health professionals. This code of ethics, to which I commit my signature, expresses values and principles essential to that end.

Public health addresses fundamental causes of disease. As such,

I will seek to promote community health in ways that respect and protect the rights of individuals and communities.

I will attempt to improve community health in ways that are sensitive to diverse values, beliefs, and cultures of people.

I will seek opportunities for input from persons affected by my initiative when developing or implementing specific policies, programs or priorities.

I will work to empower disenfranchised community members to ensure that basic resources and conditions necessary for health are accessible to all.

I will maintain competencies and skills developed through my education and practice so that I can effectively acquire and disseminate information necessary to implementing sound policies and programs.

I will act in concert with other health professionals to encourage comprehensive resolutions to community health concerns, and

I will strive to implement public health practices in a manner that most enhances the physical and social environment.

DELTA OMEGA CALL FOR NOMINATIONS

Beta Rho Chapter of Delta Omega, the National Public Health Honor Society, seeks nominations for Membership in four categories: Students, Faculty, Alumni, and Honorary. The mission of the Delta Omega Society and the Beta Rho Chapter is to encourage and recognize scholarship and research among students undertaking graduate

study; and to acknowledge alumni, faculty, and public health professionals who have truly distinguished themselves through academic achievement, advancement of public health research, excellence in public health practice and leadership in the field.

Graduates from the 2015-2016 academic year (August 2015, December 2015 and May 2016) will be considered for *student membership*. Membership is based on a number of qualifications, including: class rank, leadership, and career plans. New members will be voted on during Delta Omega's annual membership meeting in late April. Students are eligible to apply for membership if they have completed their coursework (except for spring 2016 courses) and their written capstone project/thesis by **Friday, April 8, 2016** and have registered to graduate in May 2016. *Please note: Students anticipating a May 2016 conferral must submit a signed copy of their approval page with the rest of the application.* Students earning a dual degree (e.g., MD, DMD, MSW, etc.), and who will not complete the second degree for May conferral, may apply for student membership at the time that they graduate with their second degree.

Faculty members will be considered based on outstanding public health performance in scholarship, teaching, research and the quality of publications.

Alumni from the UConn MPH program who are currently working in the practice of public health and whose work serves as a model for future graduates will be considered.

Honorary membership will be limited and conferred only upon persons possessing exceptional public health-related qualifications.

The deadline for submitting Faculty, Alumni and Honorary nominations is Monday, May 4, 2016. The deadline for a Nominee to submit his/her application and Curriculum Vitae is 5:00 p.m. on April 8.

- Abstracts must be submitted electronically; go to www.cpha.info.
- All components of the submission form must be completed in their entirety.
- Abstracts must include at least 3 learning objectives.
- Presentation topics should be pertinent to the theme of the conference ("*Back to the Future - 100 years of Public Health in CT and Beyond*"). Some ideas include: History of Public Health in CT, Public Health Successes and Challenges, Future of Public Health in CT, Future Public Health Innovations, Recognized Public Health Professionals & How They Are Making a Difference, Current Topics Affecting our State and Nation such as Opioid Addiction and TBI/Concussions, Public Health Diversity, Policy and Public Health
- Abstracts must not include trade or brand names.

ALUMNUS TOM MEEHAN
RECEIVES CPHA'S
HUNTINGTON AWARD

Each year CPHA presents *The Charles G. Huntington III Award* to a Connecticut health care practitioner who has demonstrated public health leadership and a commitment to the health and well-being of populations. The 2016 recipient is UConn alumnus **Thomas P. Meehan, MD, MPH (1992)**, Harvard Pilgrim Health Care in Hartford.

Dr. Meehan is a committed primary care provider, leader, researcher, and teacher dedicated to improving CT's health care system and to supporting those working within it. He began his career in primary care, working for seven years in the Waterbury area caring for patients of all socioeconomic backgrounds. Between 1998 and 2013, he served in Yale-New Haven Hospital's hypertension clinic, in which he cared for referred patients, many underinsured, with refractory hypertension. Throughout his entire 15 years working in Yale's hypertension clinic, Dr. Meehan was a volunteer.

Motivated by his passion for public health and quality improvement, Dr. Meehan earned his MPH degree from UConn in 1992 and became involved in leadership, with noteworthy positions including Chief Medical Officer of Qualidigm (non-profit quality improvement organization) and more recently, Associate Medical Director of Harvard Pilgrim Health Care (not-for-profit health plan). As a leader, Dr. Meehan has sought opportunities to improve safety net programs (Medicare and Medicaid) and to eliminate health disparities across all settings of care.

Dr. Meehan has taught at UConn, Yale, and Quinnipiac over the last 26 years, working with students in medicine, nursing, and public health, and continues to work with UConn MPH students as an instructor and preceptor. In addition, he has published 69 original research papers regarding quality improvement in health care. Dr. Meehan's career objective is to make a meaningful contribution to society by facilitating improvements in healthcare quality, safety, and cost-effectiveness.

The award Dr. Meehan is receiving honors **Charles G. Huntington III**, a leader, role model, dedicated humanist, steadfast public health advocate and caregiver of the first order. Charles Huntington was a leader in the physician assistant profession, a leader of the Connecticut Public Health Association for many years, and at the time of his death, was Associate Dean and Associate Professor at the University of Connecticut School of Medicine. His faculty appointment was in the Department of Community Medicine and Health Care. For several years he taught an MPH elective in strategic planning and was also a major or associate advisor to several MPH students.

JOBS IN OUTCOMES RESEARCH

The Center for Outcomes Research and Evaluation (CORE), Yale University/Yale-New Haven Hospital, is a leading national outcomes research center working on high impact projects designed to assess healthcare quality and evaluate clinical decision making and comparative effectiveness of critical healthcare interventions. Its mission is to improve health and health care through targeted research and evaluation projects that combine scholarship and service to have a positive impact on policy and people's lives. The Center is comprised of a fast-paced multidisciplinary team working at the intersection of science, health care quality and policy. All applicants should have both strong analytical skills and communication skills and experience working with clinical or health care data. The Center is currently recruiting for the following full-time research position:

Project Manager--responsible for the planning and successful implementation of multifaceted research and government/nongovernment contracts and projects for CORE. The project manager develops timelines, resource needs, standard procedures,

protocols, training documents and quality control systems to ensure adherence to scientific methods /protocols, regulatory and contract requirements, and production of high quality deliverables on time to meet sponsor needs. He/she researches, analyzes and compiles information; composes high quality status reports, technical reports and publications; effectively communicates and facilitates teams in a multidisciplinary matrixed environment; and continually seeks opportunities to increase customer satisfaction and improve quality and efficiency of project operations

Candidates should have a Master's degree, preferably in public health, business administration or a related healthcare field, and a minimum of five years of experience as project manager/coordinator of complex projects in healthcare research, health care quality, or other related area.

Senior Project Manager--The Senior Project Manager has the responsibility for managing CORE government and nongovernment contracts and grants. This high-level position requires substantive knowledge and experience directing health services research, quality measurement development or related work in healthcare. He/she will ensure that all project activities are carried out according to project timelines, that deliverables are met and that resources are within the established budget. In addition, this individual will have a clear understanding of the overall grant and contract, and will effectively communicate the project/contract status to CORE administrative staff and funding agency. The senior project manager will possess a clear understanding of the management of CORE federal and non -federal contracts including technical and business contractual requirements.

The position requires a Master's Degree in public health, nursing, healthcare management/ administration, business administration (MPH, MHA, MBA) or related field. (Project Management Professional Certification is preferred.) CORE also seeks someone with a minimum of three years' experience in a research capacity and a minimum of three years in a managerial/project management capacity or related experience indicating ability to communicate with people, to work with minimal supervision, to conduct and coordinate research studies, to prepare for and conduct team/staff meetings, to work with a variety of computer software programs, and to be receptive to a variety

of duties to support projects and to manage multiple tasks simultaneously.

Research Scientist-- The Research Scientist, Quality Measurement Programs (QMP) leads in the development, maintenance, and implementation of national health care quality measures and advances measurement methods. Reporting to the Director of QMP, the primary role is to serve as Technical Lead for specific deliverables for a large Centers for Medicare and Medicaid Services (CMS) funded multi-year contract developing and maintaining hospital quality measures for national public reporting and tracking quality trends. The research scientist provides technical leadership and content expertise for the development of deliverables under the guidance of the Director, QMP working with a diverse team of consultants, statisticians, clinicians, health services researchers, and project support staff to meet contract deliverables.

Statistician I-- Working under the direction of the Director of Data Management and Analytics, the Statistician I develops statistical analytic plans and programming in support of research projects for multiple clinical and epidemiology studies of cardiovascular outcomes research; and investigates, analyzes and evaluates complex statistical and programming problems.

The position requires a Master's degree in Statistics, Biostatistics, Epidemiology or related field, and a minimum of six months to one year of experience in conducting analysis; experience conducting analysis of health outcomes and quality of care is preferred.

Statistician II-- Working under the direction of the Director of Data Management and Analytics, the Statistician II provides comprehensive statistical support for quality of care and outcomes research studies, including managing and integrating data from various sources, developing analytic plans for research projects, conducting analyses, presenting the results, and preparing the results for publication. The Center is looking for someone who desires to contribute to the design and analysis of CORE's research projects and seeks substantive scientific and statistical responsibilities and contributions. Applicants will have the opportunity to apply data analytics directly to real-world problems that are important for patients and policy

makers. Successful applicants will have the opportunity to contribute towards a growing field that is likely to shape the delivery of health care in the future. There will also be opportunity to work with experts from the US and other countries and to publish high-quality work in technical reports and peer-reviewed journals.

A Master's degree with experience in public health, biostatistics, or related field is required, while a PhD degree is preferred. The position also requires three to five years' experience in data management and analysis including database design, statistical data analysis and reporting of clinical research studies and/or quality improvement projects; and experience in managing and integrating large datasets using a variety of software packages, including SAS, EXCEL, STATA, JMP, and MS ACCESS. Clinical experience is desired.
