### FELLOWSHIP FUND MATCH EXTENDED

The MPH Alumni Board recently established the Joan Segal Fellowship Fund for Public Health to

#### HEALTHCARE FELLOWSHIP

The Capital Area Health Consortium is seeking applications for the **T. Stewart Hamilton, M.D. Fellowship in Healthcare Management**. #### APHA FELLOWSHIP IN GOVERNMENT

The American Public Health Association (APHA) has announced a call for applications for the **2015-16 APHA Public Health Fellowship in Government**. This is the eighth year APHA is offering this fellowship, which has been described as an “amazing” and “phenomenal” experience by previous fellows. Candidates must have strong public health credentials and be interested in spending one year in Washington, DC working in a congressional office on legislative and policy issues related to health, the environment or other public health concerns.

The fellowship will begin in September 2015 and continue through August 2016. This opportunity provides a unique learning experience and demonstrates the value and need for basing policy on sound science. Throughout the year, the fellow will gain practical knowledge of government and how the public policy process works.

All candidates must:

1. be an APHA member.
2. have a graduate degree in a public health or a related discipline.
3. have five years' experience as a public health professional beyond graduate or medical training.

#### HEALTH AND EQUITY FELLOWSHIP

Human Impact Partners (HIP) is now accepting applications for its Health and Equity Fellowship Program. From June 2015 – May of 2016, HIP will host one Fellow focused on building his or her leadership and skills in the fields of Health Impact Assessment (HIA) and Healthy Public Policy (HPP)/Health in All Policies (HiAP).

This full-time fellowship, based out of HIP's office in Oakland, CA, includes training in the practice of Health Impact Assessment, and in the application of other approaches to integrate health and equity into public policy and planning decisions. Fellows will be provided with ongoing education and training throughout the program, as well as opportunities to interact and network with leaders from the fields of HIA, HPP/HiAP and beyond who have succeeded in encouraging the consideration of health and equity in decision-making processes.

Following an orientation to HIP's work, the Fellow will initiate and lead his or her own project using Health Impact Assessment, Healthy Public Policy/Health in All Policies or another approach aimed to advance the consideration of health and equity amongst decision makers and other diverse stakeholders. The Fellow-led project will be conducted under the supervision and guidance of a mentor on HIP's staff of experienced professionals. HIP staff will work with the selected Fellow to refine proposed ideas for the project. In addition to this project, the Fellow will also participate in the conduct of one of HIP's HIA or HPP/HiAP projects as a part of a team of HIP staff.

The Fellow will be hired as an employee of HIP and will receive a salary of \$60,000, as well as full health benefits. Travel expenses for assignment-related activities and professional development opportunities will also be covered.

Human Impact Partners seeks talented, self-motivated individuals committed to health and

equity for all who also meet the following requirements:

- Completion of a master's degree, or equivalent experience;
- At least 2 years of relevant job experience;
- Strong research skills; and
- Strong writing skills.

Applicants should also demonstrate an interest in a career that aims to focus on addressing health and equity, and in HIP's values of equity, community, justice, and inter-connectedness; sustained engagement with communities that are underrepresented in decision-making processes; the ability to work well with diverse groups; and strong personal initiative and motivation. Other experiences that would be an asset include experience conducting participatory research and community organizing, and mastery of at least one language commonly spoken in the U.S. in addition to English.

#### INTERNATIONAL RESEARCH ASSISTANT

There is an opening for a Research Assistant (RA) to work on a maternal health project with the "Anthropology of Public Health in South Asia" Research Group at the Centre for Modern

Indian Studies at the Georg-August-Universität Göttingen in Germany. The RA is expected to help implement and manage a qualitative study of Maternal and Neonatal Health (MNH) outcomes in relation to quality of and access to Emergency Obstetric and Neonatal Care (EmONC). The RA will be based at the University of Göttingen, but required to conduct extensive fieldwork in the Ladakh region of the Indian Himalaya on MNH indicators and outcomes in two adjacent districts. The RA will be responsible for managing the research project and team in Ladakh, as well as teaching and administration duties at the Centre for Modern Indian Studies. The Centre is seeking a self-motivated MPH student who can work with minimal supervision in the field with laypeople seeking health services and healthcare staff/officials in rural India.

The successful candidate will have the following qualifications:

- An MPH (Masters in Public Health) with a concentration in RH, SRH, or Socio-Medical Sciences from USA, Europe, or India (Medical Anthropology background also valid)
- Experience working in India, ideally in MNCH, RH, social medicine, or at the health systems level
- Solid qualitative skills; some quantitative or data analysis skills (e.g. SPSS, SAS, STATA or NVivo); and health systems research skills
- Teaching assistant experience
- Excellent verbal and written English; Hindi or Ladakhi preferred (German not required)

The Public Health Foundation's "TrainingFinder Real-time Affiliate Integrated Network" (TRAIN) is a free, online learning management system designed for members of the public health workforce. The Connecticut Department of Public Health is a state affiliate and has access to its own unique Connecticut portal. Membership is free and open, but registration is required. See the TRAIN-CT website for registration and membership details: <https://ct.train.org/>.

TRAIN-CT makes available a broad range of free courses to anyone who has registered. The following "courses," which address important topics of health equity and the social determinants of health, are currently available via TRAIN-CT and are recommended:

**Unnatural Causes: Is Inequality Making Us Sick?** A seven-part film series produced by California Newsreel (2008).

**Race: The Power of an Illusion.** A three-part film series produced by California Newsreel (2003).
