REACCREDITATION SITE VISIT IN NOV.



For the past year or two in particular, the MPH Program administration, faculty and

advisory committee have been hard at work undertaking a thorough self-study of the program in

preparation for a an accreditation site visit by the Council for Education in Public Health (CEPH), the accrediting body for schools and programs of public health. Those schools and programs who meet the exacting "gold standard" for the study of public health are CEPH-accredited. The UConn MPH

Program has been fully accredited since October 1984.

The self-study each school or program must undertake periodically addresses the program's strengths and weaknesses in several domains:

- The overall program—Mission, Evaluation, Institutional Environmental, Organization and Administration, Governance, Financial Resources, Faculty and Other Resources, Diversity
- Instructional Programs
- Creation, Application and Advancement of Knowledge
- Faculty, Staff and Students

At UConn, this effort has involved an immense amount of time and effort, particularly on the part of the Program Director, David Gregorio; Program Coordinator, Morgan Spencer; and Program Staff, Barbara Case and Laurie McCarthy. The Program's Advisory Committee, comprised of faculty, alumni and students, as well as the Executive Committee, have also played important roles.

MPH FACULTY TEACH IN CHINA



The University of Connecticut is a part of a global group of universities called Universitas 21 along with Fudan University in Shanghai, one of the leading universities in China. As a result of this university to university relationship, Drs. Stephen Schensul and Jean Schensul were invited in July. 2015 to teach a one-month summer course at Fudan. The class consisted of 21 medical, public health and social science students, with remarkably good English language skills. As in the International Health course Dr. Schensul teaches in the UConn MPH program, the students focused on a country and a health problem and, using SPSS, analyzed Demographic and Health Survey (DHS) data from their selected countries. In addition, they met with University officials to discuss future exchanges and collaborations with UConn.

The course schedule involved teaching three days a week, allowing the Schensuls to travel to Beijing on a train that reached the speed of 193 miles per hour; to Suzhou, a city of gardens from several dynasties and to nearby Chongming Island in the Yangtze River. In Beijing they met with the head of the Department of Epidemiology at Peking Union Medical College and the head of a children's hospital--both colleagues of Dr. J. Schensul when she worked in China in the 1990s and each interested in further collaboration. (The picture above depicts Dr. Schensul with his International Health students at Fudan University.)

HEALTH POLICY FELLOWSHIP



A fellowship opportunity is available in the Office of Disease Prevention and Health Promotion's (ODPHP) Division of Health Care Quality within the Office of the Assistant Secretary for

Health (OASH), Office of the Secretary (OS), at the U.S. Department of Health and Human Services (HHS) in Rockville, MD.

Under the guidance of a mentor, opportunities for the Fellow may include:

- Coordinating departmental efforts to enhance patient safety, including prevention of health care-associated infections and adverse drug events.
- Supporting and helping coordinate crossfederal efforts related to key patient safety topics, including active support of Partnership for Patients (PfP) and the new Transforming Clinical Practice Initiative.
- Assisting in the development of communication materials (articles, talking points, presentations) related to adverse drug events and other health careassociated conditions.

The appointment is for one year and may be renewed upon recommendation of HHS and subject to availability of funds. The Fellow will receive a monthly stipend depending on educational level and experience and must show proof of health insurance. He or she does not become an employee of HHS or the program administration, and no fringe benefits are provided.

Qualifications include a medical degree, PhD/D.Ph., MPH, or another degree in a closelyrelated field received within the last five years. Applicants with a Bachelor's degree received within the last five years are also encouraged to apply, provided they have relevant public health academic or work experience in addition to the degree. Preference will be given to candidates with experience working in a public health environment and experience in improving health care quality.

TOBACCO TREATMENT COORDINATOR

BOOK REVIEW



Over the years, one of the things we have prided ourselves on as a program is the attention we give in the curriculum to public health law and bioethics. One of the most interesting

and more current books I have read in this area is the #1 New York Times Bestseller, *The Immortal Life of Henrietta Lacks*, by Rebecca Skloot. *The Immortal Life* was chosen as a best book of 2010 by more than 60 media outlets and as one of the 100 Books to Read in a Lifetime by <u>Amazon.com</u>. The book explores bioethical issues, including informed consent, through the story of Henrietta Lacks, whose HeLa cells became the first and most commonly used human cell line and which have generated breakthroughs in cell biology, drug discovery, and understanding of human disease.

The book also tells a story of the collision between ethics, race, and medicine; of scientific discovery; and of a daughter consumed with questions about the mother she never knew. The story of Henrietta Laks is central to emerging issues on the ethics of genomics and personalized medicine. Who owns our cells? What is the responsible use of genetic information? How can our genetic privacy be safeguarded in an era of personalized genomics? Together, Rebecca Skloot and the Lacks family provide an important contemporary story on the use of human cells in biological research and the numerous ethical issues that are raised by the story of Henrietta Lacks.

On September 24, the UConn Institute for Systems Genomics sponsored a visit by author Rebecca Skloot and the Lacks Family to the University of Connecticut. In her talk Ms. Skloot spoke about how her obsession with Henrietta Lacks was rooted in an offhand remark by her biology instructor in a community college class and the years it took to gain the confidence of the Lacks family. If you have an interest in bioethical issues, or just simply want a "good read," here is something to think about during the December-January intercession!
