Connecticut Medical Orders for Life Sustaining Treatment (MOLST) Pilot

Connecticut is launching a MOLST (Medical Orders for Life Sustaining Treatment) Pilot Program. EMS may encounter patients who have MOLST paperwork, which spells out the patient's medical wishes. The paperwork will be a distinctive green.



EMS PROVIDERS SHOULD LOOK FOR THE

MOLST FORM TO BE ATTACHED TO THE REFRIGERATOR of the MOLST Pilot Participant living outside of a formal health care setting.

The MOLST will NOT replace a valid CT DNR. The MOLST will however hopefully better define preferences regarding life-sustaining interventions near the end-of-life.

If the patient has a valid CT DNR and the patient is in arrest, proceed as normal. If the patient does not have a DNR, but has a MOLST form, consider the MOLST form preferences in initiating care, and contact medical control as necessary.

For those services sponsored by UConn Health/John Dempsey Hospital, the MOLST form will serve as a standing order.

The MOLST Form is being piloted by UConn Health/John Dempsey Hospital and Windham Hospital. Patients discharged from these facilities may have MOLST paperwork. Target date for the project is likely to be July 1. Stay tuned for more information, and if possible attend the UConn CME on June 17 at East Farms Fire where Dr. Richard Kamin will be speaking on MOLST.

UCONN Health S.A.V.E. Stroke Test

At the 1st Annual UConn Health Emergency Stroke care Conference in May, the new UConn Health S.A.V.E. Stroke Test was unveiled. The test is a tool to use to help recognize stroke when the Cincinnati stroke scale is 0. The tool was developed after analyzing EMS stroke data in an effort to improve stroke recognition. Sudden altered mental status, vision changes or equilibrium/vertigo without explanation such as trauma, intoxication or past history of similar symptoms should arouse suspicion of stroke, particularly if the patient has risk factors such as hypertension, atrial fibrillation or cardiovascular disease. If the Cincinnati Stroke Scale is 0, but the UConn S.A.V.E. test is positive, consider stroke in your differential diagnosis.





UCONN S.A.V.E. STROKE TEST

If your patient scores a 0 on the Cincinnati Stroke Scale, ask these questions:

S- Sudden Did the patient's symptoms happen

suddenly and without an explanation such as trauma or intoxication?

A - Altered Does the patient present with altered

mental status?

V-Vision Is the patient experiencing sudden

vision problem?

E-Equilibrium Does the patient have an altered

equilibrium or vertigo

A yes to the first question and a yes to any of the following three questions should heighten your suspicion of stroke as a possible cause of the patient's condition.

Trauma Case of the Month

Patient found on ground after tripping over curb, complains of knee pain.

No distal pulses in right lower extremity.

Right knee posterior dislocation. Right popliteal artery has no blood flow below knee.

Patient went to OR. Received vascular shunt/bypass and external fixator device.



Bottom line: Check Distal Pulses!
