Cardiac Arrest Save!


A father collapsed while watching his daughter at a sporting event. He received immediate bystander CPR from an offduty police officer. EMS arrived on scene. **American Medical Response** paramedic Mathew Kozloski delivered a 300 joule defibrillation while his partner Christopher Bussiere took over compressions. **UCONN Fire Department**


ed the patient. Within ten minutes, the medics had pulses back. Little, with help from his partner Josh Levin, sedated the man who was now starting to buck the tube. The UCONN medics initiated hypothermia therapy to help preserve the patient's

brain function and did a 12-lead ECG which revealed an anterior STEMI. A STEMI alert was called to **John**



Dempsey Hospital. The cath lab was activated 8 minutes prior to patient arrival. The patient was further stabilized

in the ED, and then taken to the cath lab. The 100% occlusion in his Left Anterior Descending Artery (LAD)



was cleared and stented. The patient did remarkably well and, thanks to the efforts of many, returned home to his family just four days later. Great job, Life Savers!

STEMI Kudos


Aetna Ambulance paramedic David Noyes and his partner Kelly Shapiro responded to a sixty-two year old patient with a significant cardiac history,



who'd been having chest pain for an hour. Noyes did an immediate 12-lead ECG, which revealed a massive inferior infarction. He called in a STEMI Alert to the **John Dempsey Hospital** ED. Based on his radio patch, Dr. Sasha Gorenbeyn immediately activated the cath lab (16 minutes before patient arrival). The patient received a heparin bolus in the ED, and then went right up to the cath lab on the EMS stretcher. The patient was found to have a totally occluded SVG (saphenous vein graft) to the PDA (posterior descending branch). He underwent a successful thrombectomy and stenting restoring perfusion. He is doing very well thanks to the great job by the combined EMS/ Hospital STEMI Team. **41 Minute Door-to-Balloon time! 73 Minute EMS-Contact-to-Balloon Time!**

- 1. Resuscitate on Scene
- 2. Avoid Interruptions in Compressions
- 3. Paramedics Should Charge Defibrillator Prior to Rhythm Check
- 4. Avoid Hyperventilation


