GME	<p>GME has had several recent ACGME site visits and have several more in the future. Most are routine site visits scheduled a few years after a new program starts. One site visit is happening due to a poor resident survey; GME has already developed action plans based on their interpretation of the survey results.</p> <p>GME policies and procedures are being transitioned into the new Policy Manager system. No substantive changes to the content of GME’s policies/procedures are expected, but rather just reformatting to get them into the new software. Migration is expected to be complete by Summer 2024.</p>
