


Register for online account access






Go to LincolnFinancial.com/Retirement and select **Register**.

Before you access the website, set up your security profile by completing Steps 6 through 8.

6.

First, select your personalized security image and phrase.

7.

Next, select three different security questions and provide answers to each. Answers must be at least three characters. You'll be directed to your Lincoln website home page to enroll in additional security measures.

8.

Register a telephone number to enroll in mandatory two-factor authentication. We'll send a confirmation code to your phone via your chosen method — either a text message or a phone call.

9.

During your next login, Lincoln will send a six-digit code to your phone via your preferred method. Enter the code into the website to complete your login.

You have the option to select "Remember this device." If you click this button, you won't be prompted for two-factor authentication on that device for 120 days.
