Letter from the Director

Having the opportunity to join forces with health leaders from across the country to host this unique, solutions-focused virtual convening was a true labor of agape love. We are equally as excited and humbled by the outpouring of sponsorship we received. Each of the grants and contracts we secured this year will assist us with furthering our mission. However, we fully recognize that these accomplishments are not ours alone. Rather, they illustrate what happens when passion meets political will and strategic alignment. I feel extremely blessed to have the opportunity to lead the HDI alongside faculty and staff so deeply committed to eradicating structural racism and other divisive forces at the root of health disparities. I am looking ahead to FY 2022 with great anticipation and radical hope. There is so much sacred work ahead.

Overview of FY'21

HDI has sustained and deepened its work in health equity among boys and men of color across our focus areas of:

- Pover the past year, the mission and legislative mandate of the UConn Health Disparities Institute (HDI) to eliminate health disparities and advance health equity have continued as a national priority during the unrelenting COVID-19 pandemic and movement for racial justice.
- · Behavioral health:
- Neighborhoods, housing, and health;
- · Healthcare delivery, finances, and services utilization; and
- Chronic disease prevention and control.

Within these focus areas, HDI continues to leverage its four strategic approaches to advance health equity and reduce health disparities:


- Enhance health equity research, training, and innovation.
- Deepen community engagement and cultivate cross-sector collaborations.
- Support policy action and systems change.
- Change data-driven and public narratives about vulnerable populations.

From July 2020 through June 2021, HDI has achieved several milestones. We hosted the largest event in our organization's history—the State of Health Equity among Boys and Men of Color Summit and Ideas Lab—where we celebrated boys and men of color and re-imagined innovative solutions to advance health equity. In partnership with the UConn Foundation, we

raised over \$150,000 in event support for the Summit. We brought in \$170,000 in new funding from the Commonwealth Fund and the CT Health Foundation for our work in behavioral health among CT's Medicaid recipients. We redesigned the HDI website, started the HDI newsletter, and launched a causality website dedicated to translating advanced statistical insights for general audiences. Dr. Victor Villagra, former Associate Director of HDI, influenced national policy action from Senator Chris Murphy's office with his work on medical debt. Dr. Wizdom Powell, Director of HDI, was awarded R34 funding from NIDA for Project BrEAtHe (Brothers, Reclaiming, Emotional, Awareness, Tranquility, Healing, & EX-istence): Disrupting Racialized Stress, Trauma, & Problematic Substance Use in Young Adult Black Men.

This year, the HDI team bid farewell to Dr. Villagra, who retired from his Associate Director position. Dr. Villagra's expertise and contributions to health insurance literacy, simplification, and navigation and medical debt have been invaluable assets to HDI, the state of CT, and the national conversation on reducing healthcare disparities.

Our highlighted accomplishments and more are included in this report as well as HDI's initial plans for the coming year.



On June 8-11, 2021, the UConn Health Disparities Institute hosted the inaugural State of Health Equity among Boys and Men of Color Virtual Summit and Ideas Lab.

SUMMIT

This unprecedented, one of a kind, global Summit featured solutions-driven, interactive, and high-powered sessions that employed arts-based approaches along with intergenerational dialogues designed to amplify youth voice. The virtual convening aimed to ignite public discourse and action to advance health equity, racial justice, and systems change for radical healing among boys and men of color.

The Summit was organized by an over 60 member planning committee—including members of our BMOC Alliance—representing approximately 30 organizations. As part of the planning committee, the Youth Planning Council ensured youth voices were a central piece of the Summit. The convening hosted 95 speakers and 18 artists, performers, & storytellers for an audience of 243 people globally. Our speakers and artists focused on the following theme areas:

- 1. Behavioral Health
- 2. Trauma
- 3. Incarceration & Justice
- 4. HIV/AIDS

IDEAS LAB

After the Summit concluded, it was time to take action! The companion event, the Ideas Lab, took place on June 11. It is an incubator that focuses on developing and providing seed funding for innovative solutions to complex problems by harnessing the collective creative energy of a multi-sector team. Thirty-two (32) people participated and are currently preparing proposals for seed funding. HDI plans to fund three (3) teams at \$15,000 each for one year. A selection committee will evaluate each proposal submission based on a rigorous scientific review process to determine which projects to fund. Projects are anticipated to begin in fall 2021.

HDI designed and released the Digital Summit Toolkit for all attendees, speakers, sponsors, and planning committee members to continue learning, discourse, and action from the Summit. Behavioral Health and Telehealth Services Utilization Among CT's Black Medicaid Recipients

In FY'21, HDI received new funding to bolster and expand our work in behavioral health disparities, particularly given the impact of the COVID-19 pandemic. With support from both the Commonwealth Fund and the Connecticut Health Foundation, HDI is conducting a study to explore the impacts of COVID-19 on telehealth use for behavioral healthcare among Black adult Medicaid beneficiaries in CT.

The purpose of this study is to:

- Investigate patterns of behavioral health services utilization among CT's Black adult Medicaid beneficiaries using Medicaid claims data;
- Examine the geospatial distribution of the Medicaid-eligible behavioral health services (in-person, telehealth, and telephonic) they access using PolicyMap and GeoDa; and
- 3. Explore potential socially determined barriers to and facilitators of services utilization.

In addition to analysis of Medicaid behavioral health claims data, this mixed-methods project includes a qualitative arm inclusive of in-depth interviews (IDIs) with Black adult beneficiaries, and Delphi sessions with key stakeholders (Medicaid staff and behavioral health providers), to gather perceptions of the effectiveness of CT's Medicaid program in facilitating adjustments to behavioral health services delivery amidst the COVID-19 pandemic. Furthermore, we explore facilitators of and barriers to telehealth behavioral health services access, delivery, and access among Black adults. Taken together, this information will be used to inform Medicaid policy, administration, and

systems transformation in CT. Such data will also yield powerful insights about the role of social determinants of health in Black adult beneficiaries' behavioral health services use patterns, and the geospatial distribution of Medicaid-eligible services they utilize.

Over the past year, HDI has achieved several key project milestones. HDI has:

 Assembled a point-level dataset of all Medicaid eligible behavioral health services locations in Connecticut with telemedicine capabilities. Analyses of these data are currently underway (PolicyMap and GeoDa) to identify the geospatial distribution of these locations/services across Connecticut.

- Reported the first set of findings on geospatial distribution of behavioral health access points in CT in a policy brief entitled, Does telehealth reduce geographic barriers to behavioral healthcare for Connecticut's Medicaid beneficiaries of color?, which will be published on the HDI website and via the Commonwealth Fund in the near future.
- Initiated recruitment of Black males to participate in in-depth interviews about their experiences accessing telebehavioral health services through Medicaid before and during the pandemic. HDI is recruiting through established points of contacts, including Amplify, Inc., Charter Oak Health Center, Family Medicine Center at Asylum Hill, and other partners through the Community Health Center Association of Connecticut. The project team has completed two IDIs to date.
- Received the first round of CT Medicaid claims data for analyses. After months of a lengthy negotiation, HDI reached an agreement with CT Medicaid regarding the specifications of the claims data request and obtained a fully executed data use agreement in July 2021.

Healthcare Delivery & Telehealth Projects Partnership

In partnership with the UConn Health Center for Quantitative Medicine and Dr. Tom Agresta, HDI worked on a telehealth project funded by the Community Health Center Association of CT (CHCACT). The purpose of this project was to evaluate health center operations data, patient data, and billing data to determine the impact telehealth has had on the federally qualified health centers during the COVID-19 pandemic. The project objectives included:

- Measure utilization of the various components of telehealth;
- Measure the impact, positive or otherwise, on the patient population, the revenue to the health center, the cost to the state, and the potential down-stream savings that may have resulted from the use of telehealth;
- Gain knowledge of how telehealth services have impacted segments/cohorts of the population;
- Gain an understanding of the utilization patterns across various cohorts including race and ethnicity.
- Capture additional empirical data that may support the adoption of telehealth as a permanent benefit for Medicaid patients.

HDI supported provider survey development, data collection, and quantitative analysis as well as patient focus group development, implementation, and qualitative analysis.


HDI will continue its partnership with the Center for Quantitative Medicine through funding from the Office of Healthcare Strategy, to develop user-interface requirements for patient and provider facing medical reconciliation applications (an extension of Dr. Agresta's existing work on Medication Reconciliation and Polypharmacy). HDI supported the development of questions for web-based surveys and inperson focus groups. HDI will also support qualitative analyses of data collected from surveys and focus groups.

Advancing a Radical Healing Agenda & Holding Space for Boys and Men of Color

Throughout this past year, under Dr. Wizdom Powell's leadership, HDI has led several health equity initiatives to advance a radical healing agenda and operationalize holding space for boys and men of color.

This brief lays the groundwork for a radical healing agenda as an antidote for racial trauma and injustice. The authors outline five principles of radical healing to reimagine health policies and systems where Black, Indigenous, and People of Color can thrive.

Also, in partnership with the APA Division 51 members-at-large, two policy briefs on holding space for boys and men of color are slated to be published.

Radical Healing Action Team

In partnership with Amplify, Inc. and the Ministerial Health Fellowship, HDI formed the Radical Healing Action Team with organizational and community members to put the radical healing agenda into action in Connecticut. This group formed as a result of a town hall series, "Healing Covid-19 and Racism: Bridging Behavioral Health Gaps to Build Healthy Communities," hosted in July 2020 by Amplify, Ministerial Health Fellowship, and HDI. The Radical Healing Action Team designed and is conducting a landscape analysis of the radical healing principles across CT agencies and organizations. The group disseminated the policy brief to CT legislators, listserv contacts, and through social media. They plan to hold virtual interactive educational sessions on the principles and approaches for radical healing before the next legislative session.

Health Equity Week 2021

In April 2021, HDI participated in Health Equity Week (HEW) for the third year and focused on raising awareness about behavioral health disparities and a radical healing agenda. Dr. Wizdom Powell served as a panelist in the HEW launch event, "The Path to Health Equity in CT," hosted by Health Equity Solutions. HDI also

produced a student-led social media campaign on behavioral health and radical healing, including a Twitter chat and partner outreach about the meaning of radical healing.

David Makes Man



In collaboration with Dr. Powell's APA D51 Brain Trust, HDI created and released a public syllabus focused on the OWN television drama series, David Makes Man, a coming of age story about a young, gifted Black boy exploring themes of race, identity, masculinities, manhood, and more within the context of trauma exposure, neighborhood environments, and programmatic practices and structures. The David Makes Man series and public syllabus emphasize the vital importance of holding space for Black boys and demonstrate how to reimagine masculinities, transform systems, and advance health equity for boys and men of color. HDI hosted a five-part conversation series on the themes from David Makes Man in June 2021 in partnership with APA Division 51, Rutgers University Newark School of Arts and Sciences, and Big Picture Learning to further engage educators, community, parents, and families in training opportunities. Dr. Wizdom Powell hosted national experts in the health, wellness, and identity of Black men and boys as they discussed the themes of each episode of the first season of David Makes Man. Dr. Powell plans to offer a J-Mester course on the David Makes Man public syllabus to UConn ScHOLA2RS House Learning Community and Morehouse University students during the winter academic session.

Podcast



HDI released the Holding Space for Boys and *Men of Color* podcast this year. This podcast invites listeners into a series of courageous conversations between boys and men of color, thought leaders, scholars, activists, artists, and other grassroots organizers. HDI's goal is to tell whole, complex, and dynamic stories about the lived experiences, hopes, wishes, and aspirations of boys and men of color worldwide. The audience will walk away with a deeper appreciation and understanding of how boys and men of color navigate the world; a new found agape love for them; and a fierce sense of urgency to develop policies, practices, and community initiatives that better position them to heal, grow, and thrive. COVID-19 and Racial Justice

Since the beginning of the COVID-19 pandemic in the U.S., HDI has been working to respond to the dual pandemics of COVID-19 and racism. Our work has evolved over the past year with the introduction of the COVID-19 vaccine and the national discourse around vaccine hesitancy and skepticism, as well as the continued calls for racial justice and equity.

Through our COVID-19 response efforts, HDI maintains statewide and national visibility, which has resulted in HDI leadership being called to serve in the following ways:

- Invited to speak as a subject matter expert on health equity, medical mistrust, vaccine hesitancy/skepticism, racism, and radical healing at statewide and national forums, including but not limited to:

- Partnered with APA Division 51 Society for the Psychological Study of Men and Masculinities to host a fatherhood webinar, <u>Parenting</u> <u>During Periods of Uncertainty and Unrest.</u>
- Engaged by two foundations—Hartford
 Foundation for Public Giving and UConn
 Foundation—to speak with stakeholders
 regarding racial/ethnic disparities in COVID-19
 and solutions to advance health equity.
- Interviewed as a public health and racial equity expert for over 24 media pieces.

- Published four op-eds and articles on COVID-19, health equity, and racism.
- Serve as a subject matter expert to support the offices of Senators Chris Murphy and Chris Van Hollen in the introduction of federal legislation to reform medical debt and strengthen consumer protections in 2020 and again in 2021.

The event was sponsored by the Africana Studies Institute, Center for Treatment of Developmental Trauma Disorder and the Center for Trauma Recovery and Juvenile Justice. HDI partnered in this event because of its shared commitment to racial justice and foundational belief that the arts and creative expression are the most powerful vehicle for healing and transformation.

COVID-19 Data Mapping

HDI continues to leverage our data analytics expertise and the PolicyMap tool to track COVID-19 health disparities in CT. Dr. Emil Coman presents a health disparities assessment of COVID-19 infections and deaths in CT as well as maps of COVID-19 infections by town. Dr. Coman creates and updates these data weekly. HDI makes these data and maps available for public consumption. See maps presented on the UConn HDI website and Tableau.

Health Insurance Advance

Under the leadership of Dr. Victor Villagra, Associate Director, HDI concluded its Health Insurance Academy (HIA) project, funded by the CT Health Foundation, in January 2021. The conclusion of HIA marks two important milestones: (1) the culmination of a five-year effort focused on health insurance literacy, navigation, and simplification, together known as Health Insurance Advance; and (2) Dr. Villagra's retirement from HDI.

Health Insurance Academy (HIA)

HDI completed the design and production of the digital HIA modules to serve as a scalable resource to improve, at a population level, the health insurance literacy of racial ethnic minorities and non-native English speakers in Connecticut. HIA comprises 20 self-learning audiovisual modules (and 20 Spanish audio-only modules) covering topics on selecting and using health insurance. HIA modules also include related topics such as avoiding incurring in medical debt, responding to lawsuits for past due debt, and identifying racist interpersonal and institutional behaviors. HDI partnered with four community-based organizations for a time-limited, initial dissemination of the HIA modules. Amplify, Inc., Hispanic Alliance of Southeastern CT, Project Access-New Haven, and Hartford Knights Youth Organization shared HIA with their clients during the open enrollment period. Partners found the module content to be a useful tool, even for their staff to better understand health insurance. They also expressed interest in continued access to and dissemination of the modules.

Medical Debt

Dr. Villagra has also led HDI's pioneering work in medical debt through a funded project with the Hastings Center and policy action with Senator Chris Murphy's office.

Dr. Villagra advised The Hastings Center bioethics research institute on their surprise medical billing project, funded jointly by the American Board of Internal Medicine Foundation and the Ethel Donaghue Foundation. This project convened a working group of experts for deliberation sessions to identify solutions and system-level reforms to reduce/eliminate surprise medical bills and medical debt, reduce/eliminate healthcare disparities, and enhance public trust in healthcare professionals and the healthcare system. While this project began in the fall of 2020, it changed course

after the passage of the "No Surprises Act," federal surprise billing legislation included in the \$900 billion COVID-19 relief bill that went into effect at the end of December 2020. The group recognized that it would take time to know whether surprise medical billing has been addressed by the legislation and implementing regulations. After deliberation and discussion, the majority of the group expressed interest in tracking what happens with this law and learning from it, but not in further expanding the group's scope. The group decided to pause the project and reconvene when there is a need for a multi-stakeholder group to come together to address problems with the legislation, which will likely not occur for several years.

Dr. Villagra also provided valuable advice to the UConn Foundation upon receipt of a \$2 million grant from the Widows Society to support programs that focus on supplementing the medical bills of female uninsured and underinsured patients and mitigate the risk of incurring in medical debt.

Medical debt has become a national policy priority, spear-headed by Senators Chris Murphy and Chris Van Hollen. Based on his work in medical debt, Dr. Villagra serves as a subject matter expert and advisor to Senator Murphy's office. Dr. Villagra helped create and refine The Strengthening Consumer Protections and Medical Debt Transparency Act, federal legislation first introduced in 2020 by Senators Murphy and Van Hollen to reform and reduce medical debt, particularly in light of the COVID-19 pandemic. The senators plan to reintroduce the legislation in 2021 and continue to consult with Dr. Villagra. Senator Murphy hosted roundtables on medical debt throughout CT in 2021, which remains a policy focus area for the senator. Dr. Villagra and Dr. Emil Coman, HDI

statistician, joined the Hartford roundtable at Charter Oak Health Center, pictured here.

As a continuation of HDI's medical debt work, Dr. Coman has pursued funding to study credit scores and medical debt. Dr. Coman was invited to submit a full proposal to the Robert Wood Johnson Foundation for their Health Data for Action program on this topic. Although not funded, Dr. Coman has submitted a manuscript on spatial analytics and another grant application to USDA as a by-product of this collaboration.

Health Equity Leadership Initiative & Mentoring

HDI continues to advance its educational mission through the health equity leadership initiative and mentoring of students and trainees. Over FY'21, HDI invested \$7,000 in stipends for 11 student interns as part of our health equity leadership initiative. Each student intern carried out project deliverables that aligned with HDI initiatives. These projects included: the State of Health Equity Among Boys and Men of Color Summit, the Radical Healing Action Team, Health Equity Week, the CT Report Cards on Health Equity, the Visualizing Health Equity Curriculum, behavioral health projects funded by Commonwealth Fund and CT Health Foundation, APA D51, the Holding Space for Boys and Men of Color podcast, and

Dr. Coman provides data analytics support (15% effort) to the UConn Center on Aging for Dr. Lisa Barry's Aging Inmates Suicidal Ideation and Depression, "Aging Inside," R01 grant, funded by NIMH. The current focus continues to be on publications – one manuscript is under review at the International Journal of Prisoner Health and a second manuscript led by Dr. Coman on health disparities among inmates is in progress.

Dr. Coman also continues his work with the Aging Center's Data Resource Core (RC2) as a data methods and analysis content expert, providing assistance to ongoing faculty projects. The Aging Center was recently awarded a P30 Pepper Center grant, on which the HDI team will continue to partner.

FY'21 ANNUAL REPORT

The **PolicyMap tool** continues to be an investment that has demonstrated benefits to the UConn Health and larger UConn community. PolicyMap has been demonstrated to researchers at UConn Storrs researchers (e.g., InCHIP), UConn School of Social Work, and UConn Health. It has also been leveraged as an educational tool at the School of Medicine, in Dr. Kirsten Ek's clinical home class (Jan 2021). PolicyMap is featured as a central data source and visualization tool for two School of Medicine capstone projects (Chase Foster and Will Doemland).

The **Ideas Lab**, a partnership with InCHIP as part of the State of Health Equity among Boys and Men of Color Summit, has potential to generate revenue in new grant funds for innovation that comes out of the pilot projects. HDI secured \$40,000 in grant funding for the Ideas Lab from the CT Health Foundation and the Hartford Foundation for Public Giving. Teams will submit their proposals for seed funding in September and 1-year projects will begin in fall 2021. HDI expects these pilot projects to yield a return on investment as teams look for additional funding for their projects.

Brothers Reclaiming Emotional Awareness
Tranquility Healing & Ex-istence

HDI continues its work in behavioral health, neighborhood contexts, and racism-related stress among young adult Black men from Dr. Wizdom Powell's KO1 award, MANHOODS, with the newly funded NIDA R34. Led by M-PIs Dr. Powell and Dr. Susan Gaylord, HDI will partner with the University of North Carolina-Chapel Hill and the Research Triangle Institute to implement Project BrEAtHe (Brothers, Reclaiming, Emotional, Awareness, Tranquility, Healing, & EX-istence): Disrupting Racialized Stress, Trauma, & Problematic Substance Use in Young Adult Black Men. Over three years, the proposed research seeks to culturally adapt and assess the feasibility and acceptability of a validated mobile technology-assisted, instructorled, group mindfulness-based stress reduction intervention for young adult Black men residing in disadvantaged neighborhoods in Durham, NC and Hartford, CT in an effort to mitigate the escalation of problematic substance use.

P30 Pepper Center


The Aging Center and HDI are building on their existing partnership for the newly funded P30 Claude D. Pepper Older Americans Independence Center aimed at improving health and independence in older adults through a collective multidisciplinary focus on scientific approaches emphasizing Precision Gerontology. Dr. Wizdom Powell will serve as Co-Lead of the Recruitment and Outreach Core (RC1) and Allison Joslyn will serve as Research Assistant II of RC1. They will advise on and support the Center's community-based participatory research (CBPR) activities and the development of the community advisory board. Dr. Emil Coman will continue to

support the Data Resource Core (RC2) as a data methods and analysis content expert. The RC2 core has been actively providing assistance to ongoing faculty projects, before the grant was funded. HDI has worked with the Aging Center on previous P30 Pepper Center grant submissions as well.

BMOC Multisector Alliance

In FY'22, HDI will reignite the alliance as a working group to address health disparities and advance health equity for boys and men of color throughout CT and beyond. We intend to plan, partner, and prioritize together. In March 2021, we polled each of our alliance members to find out what they want to focus on as a priority area(s) for FY'22: (1st) Policy Advocacy/Translation, (2nd) BMOC Summit, (3rd) COVID-19 Support & Resources.
