## UCONN Program in Applied Public Health Sciences November, 2018

## "I never get tired of being grateful"

Our September 20<sup>th</sup> community forum (Hurricane Maria – 365 days and Counting) proved to be informative and inspirational. Panelists representing the Family Life Education Center, El Instituto, UCONN, the State Office of Emergency Services, the Capitol Region Education Council and several regional NGOs (Catholic Charities, Junta for Progressive Action, Salvation Army and Hispanic Health Council) joined with several Merelys Torres Garcia, Ashlyn Gonzalez and Dalianys Mercado Vargas to discuss the challenges of persons displaced around Connecticut in the hurricane's aftermath. Evidence of coordinated effort to address the immediate needs of these persons and strategies for improving responses to future environmental challenges were presented. We thank everyone for their generous contributions of time, talent and emotion to the program.

As a follow-up to the forum, our program faculty, students and community partners are undertaking a qualitative pilot study of the impact of resettlement on the physical, mental, social and economic well-being of individuals and households. Under leadership of Candida Flores, Executive Director of the Family Life Education Center, a cohort of community members will work with MPH students to design and implement qualitative assessment tools to explore the impact of resettlement on employment, healthcare, housing, social support, food security, public safety and domestic violence, substance use, child development, transportation, culture and community cohesion.

Tara Lutz, MPH, PhD has been appointed to the CPHA Board of Directors.

### **Public Health as Social Action**

The Trump Administration is considering a change in the definition and application of the term "Public Charge". The current definition reads "an individual who is likely to become primarily dependent on the government for subsistence, as demonstrated by either the receipt of public cash assistance for income maintenance or institutionalization for long-term care at government expense." The Secretary of Homeland Security proposed that immigrants who not "primarily dependent" on the government but receive food stamps (SNAP), WIC benefits, subsidized housing (Section 8) and/or Medicaid insurance will be deemed Public Charges and be ineligible to become permanent legal residents (i.e., green card holders). As such, this change will be unfairly force some to choose between needed health and human services and legal immigration status in the United States. ## **Faculty News**

We are sad to announce the death of Dr. Howard Bailit, Professor Emeritus. Howard's contributions to our program were numerous, as were his scholarly accomplishments on topics of health policy and economics. He was, since 1984, a member of the Institute of Medicine National Academy of Sciences, author of more than 200 papers, recipient of \$43 million in grants and a member of many national committees and editorial boards.

Professor Judy Lewis is being recognized at this year's APHA Annual Meeting (San Diego, CA November 10-14). She is recipient of The Carl Taylor Lifetime Achievement Award in International Health for her visionary leadership in shaping the direction of International Health within APHA. Her nomination for the award acknowledged her lifetime dedication to advancing global maternal and child health "through respectful, long-term interdisciplinary partnerships that address local (and locally identified) community health issues and priorities."

"Judy's approach has always centered on active listening and learning first. She believes that if we understand community members' perspective and beliefs, we can work with them to improve health.... She was doing 'service learning' before it had a working name."

Like the selection committee for the Carl Taylor Award, we are inspired by Professor Lewis' many accomplishments. Her contributions to the UCONN School of Medicine's Global Health Education Program and our MPH program are numerous. In Haiti, alone, she has worked with more than 50 students on projects to improve health care delivery and health outcomes. She was founder and current Chair of the Women, Children and Adolescent Workgroup of the World Federation of Public Health Associations and she helped create The Network: Toward Unity for Health; Women and Health Together for the Future (WHTF). She has been a member of APHA and the CT Public Health Association since the 1970s. **Congratulations!**

#### **Executive Director, CT Association of School Based Health Centers (CASBHC)**

The CASBHC seeks a dynamic full-time Executive Director to lead Connecticut's network of over 100 school based health centers. Connecticut's School Based Health Centers (SBHCs) are comprehensive primary health care facilities licensed as outpatient clinics or as hospital satellites. The SBHCs are located within or on school grounds and serve students in grades pre-K-12. The Executive Director will lead CASBHC's advocacy on behalf of the entire network, as well as leading CASBHC's own fund development and overall management. The Executive Director must have excellent networking, communication and project implementation skills.

Key Responsibilities of the CASBHC Executive Director:

The new Executive Director will:

- Provide strategic leadership to drive organizational success and impact in an ever-changing environment.
- Support and build the CASBHC Board in its work to advance the organization's mission, assist with fundraising, and carry out its responsibilities for organizational oversight.
- Represent CASBHC in coalitions and on committees that impact child and adolescent health; use advocacy, collaboration and communication to expand support for the work and funding of school-based health centers.
- Initiate, organize and deliver CASBHC strategic initiatives, consistent with CASBHC's strategic plan.

- Oversee the conference and training functions delivered by CASBHC.
- Develop and deliver on CASBHC's communications plan.
- Manage a \$240,000 budget, working closely with CASBHC's accountant, and, through grant-writing and other activities, generate new and diversified fund sources.
- Manage a small group of staff, consultants, interns and volunteers, expanding operations as funds become available.
- Sustain CASBHC's non-profit fiscal, insurance, and compliance structures.

#### Torrington Area Health District, W.I.C. Program Nutritionist

The W.I.C. Program Nutritionist shall be responsible for the nutrition and breastfeeding promotion and support services component of the TAHD WIC Program along with administrative duties as assigned by the W.I.C. Coordinator. The Program Nutritionist is the WIC service area "nutrition team lead" and must be present at least eight (8) hours per month at each permanent site. Duties of the position include:

- Develops the nutrition and breastfeeding promotion and support services component of the annual local agency plan. Ensures compliance with Federal and State regulations and guidelines. Encouraged to work with the Site Nutritionist and/or local agency Breastfeeding Coordinator
- Participates in the development of the nutrition and breastfeeding promotion and support services budget.
- Implements the nutrition and breastfeeding promotion and support services component of the local agency plan
- Assures proper certification of eligible applicants
- As a Competent Professional Authority (CPA) on the staff of the local program, conducts a complete WIC nutrition assessment, determines and documents nutritional risk of WIC participants, as appropriate develops and follow-up on care plans for high-risk participants
- Is responsible for the appropriate assignment and tailoring of WIC food packages for participants
- Other duties as assigned

**Education and Experience requirements:** 

- A Master's degree from an accredited institution in nutritional sciences, community nutrition, clinical nutrition, dietetics, public health nutrition, home economics with a major in foods and nutrition and one year of responsible experience in nutrition in a health agency or health care facility, OR
- A Bachelor's degree from an accredited institution with a major in foods and nutrition, community nutrition, nutrition education, or nutritional sciences and two years of responsible experience in nutrition in a health agency or health care facility.
- Successful completion of a Commission on Accreditation/Approval of Dietetics Education (CAADE)
  accredited/approved supervised practice program (e.g., a Coordinated Program, Dietetic Internship or
  Approved Pre-Professional Practice/AP4 Program) or a Master's degree in nutrition education can qualify for

### **Chatham Health District, Sanitarian**
